TENDER NOTICE

Sealed quotations from licensed and reputed transportation companies are invited for providing Dianna/lorry/truck for transporting luggage of Indian Hajis from Madinah to Makkah and vice versa during Haj 2018. The quotations should be submitted, along with documentary evidences of company's valid license, experience, trucks and drivers details to Haj Section, Consulate General of India, Jeddah latest by May 01, **2018 (till 1700 hrs.)**.

2. Details of the services that are to be provided by the company are indicated below:

Sl. No.	Description
1.	2012 and above model
2.	dianna will be required for the respective period from <u>9th Dhu Al Qidah 1439 to 25th Dhu Al Qidah</u> and <u>21st Dhu Al Hijjah to 15th Muharram 1440.</u> The said period may slightly vary.
3.	All necessary permissions, approvals, and payments, if any, to the local Government /Haj agencies required for transporting luggage of Indian Pilgrims.
4.	Company should provide a coordinator to Coordinate with Indian Haj Mission.

Sealed tender along with required documents, should reach Haj Section, Consulate General of India, Jeddah latest by **1 May, 2018 till 1700 hrs.** Tender without proper documents shall not be entertained. The process of selection of final bidder will consist of following two stages:

A. **Qualifying stage:**

A designated committee will assess the companies based on the following criteria:

- (i) Companies should have at least 30 trucks of 2012 & above model;
- (ii) Valid license;
- (iii) Experience in the field;
- (iv) Well-equipped office in Makkah and Madinah;
- (v) Any other relevant criteria that the committee may decide.

B. **Selection stage:**

- (i) Only those companies will be considered for selection who qualify in the first stage.
- (ii) The committee will open the price bid.

Terms and Conditions

1. The Committee reserves the right to reject any or all tenders without assigning any reason thereof.
2. An agreement will be signed with successful bidder/bidders encompassing elaborate terms and conditions. The company will be given in advance the schedule of arrival of the pilgrims at each building for providing services to the pilgrims. **The selected bidder, after the agreement, has to submit earnest money of SR 30,000/- in the form of cheque/draft duly certified by Bank and payable in favour of "Consulate General of India, Jeddah".** The selected bidder will not be allowed to back off the contract and in case he is not able to provide the desired services, the Earnest Money will not be refunded to him.
3. It should be ensured that the services are provided as per the agreement. In case of non-compliance of terms and conditions or any kind of deficiency in the services, a penalty, as decided by the Consulate, would be imposed, *which may include cancellation of the contract with no payment and also blacklisting of the company.*
