



## CONSULATE GENERAL OF INDIA, JEDDAH

### HIRING OF TRANSPORTATION FOR HAJ 1440 H - (2019)

For the forthcoming Haj 2019 we intend to hire the below mentioned vehicles for the period indicated against each.

(a) **10 Buses (45-49) seater** – 2018 model (viz. Golden Dragon, Higer, King Long or Yong Tong) with Indian drivers (gasoline, comprehensive insurance) for use by its officials/officers during Haj Week 7-14<sup>th</sup> Zul Hijjah 1440 H corresponding to 9-16<sup>th</sup> August, 2019 (on this Consulate's disposal) from the Registered Pilgrim Transport Companies having valid entry permits issued by the General Cars Syndicate, Makkah to ply in Mashaier Region and Inter-city route for use by officials of the Indian Haj Mission deputed by Government of India for Haj duty.
